The Illinois Board of Examiners (ILBOE) does not release exam grades, exam locations or dates, Pass/Fail status, etc. without a signed release from the candidate. The only information released without consent and without a fee is the certification status, date certified and the certification number because it is considered public knowledge in the State of Illinois per 5 ILCS 140/Freedom of Information Act (<http://www.ilga.gov/legislation/ilcs/ilcs3.asp?ActID=85&ChapterID=2> ).
